CHAMPION

- Has been/was engaged in any competitive whitewater discipline for at least five (5) years.
- Has a distinguished record of achievement at the highest levels of competitive whitewater sport.

ADVOCATE

- Has promoted whitewater pursuits vigorously through grassroots advocacy, environmental stewardship or by producing significant products or services.
- Has served the whitewater community in a leadership role for a period of twenty (20) years or more.

Note: All nominees: 1) may be living or deceased, and 2) may be an individual or a team.

 - Two times gold, two times silver. No one has more medals in canoe slalom from Olympics.
 He managed his first victory as junior, he was 17 years old.

He has amazing history of his World Champinoships competitions - from 1995 on every WM race he got a medal.

He has also the canoe slalom "grand slam" - gold medal from Olympics, World Champs, Euro Champs and World Cup title.
